Become the Citizen NFT

1. Introduction

Welcome to the Become the Citizen NFT collection (hereinafter the "Project"). The Project is a group of non-fungible tokens ("NFTs") collections featuring original artworks created by different specialized artists selected by QORPO Game Studio for their talent and experience.

2. Scope of these Terms and Conditions

These terms and conditions (hereinafter the "Terms") govern your access to and use of the Project, including the purchase of NFTs. By accessing or using the Project, you agree to be bound by these Terms. If you do not agree to these Terms, you may not access or use the Project.

3. NFTs

The Project will issue a total of 500 NFTs on its First Edition. Each NFT is unique and represents ownership of a digital asset featuring an original artwork that embodies a copyrights license. The NFTs purchased through the Project grant their owners a copyrights license for the commercial and personal use of the work it represents, subject to the terms and conditions set forth in these Terms.

4. Purchase and Sale of NFTs

NFTs may be purchased through [Crypto.com/nft](https://crypto.com/nft) using a variety of accepted payment methods. The price of each NFT will be determined by the Project upon launch. NFTs may be resold or traded through third-party platforms such as [Crypto.com/nft](https://crypto.com/nft), subject to these Terms and any applicable laws or regulations. The Project is not responsible for any disputes that may arise from the resale or trade of NFTs.

5. License

By purchasing any NFT of the Project, you are granted a non-exclusive, worldwide license to use the copyrighted artwork embodied in the NFT for both commercial and personal purposes. The license does not transfer any copyright of the artwork incorporated to the NFT and it is limited to the following uses:

1. To alter, modify, or create derivative works based on the artwork;
2. To use the artwork embodied in the NFT for any non-commercial purpose;
3. The right to use the artwork embodied in the NFT with any commercial purpose, including but not limited to advertising, marketing, and product sales.

With the acceptance of the Terms, you are obligated to respect and comply the conditions of the license, which will be applicable to any third party who purchases any NFT of the Project in the event of resale or any other transfer of property.

6. Restrictions

Considering the above, this license does not transfer ownership of copyrights or other intellectual property rights, and you may not claim any rights except as expressly set forth in these Terms. Additionally, your use of the artwork shall not infringe any intellectual property rights of the artists or any third party, or in any way that is illegal or unethical. Also, the license granted does not include the use of the trademark or any distinctive sign owned by QORPO Game Studio.

7. Roadmap Participation

As a holder of an NFT, you will be eligible to participate in the roadmap for the Project as stated on the Project's website. This may include opportunities to provide input and feedback on future development plans, as well as access to exclusive events and other perks. The terms and conditions of your participation on the roadmap will be informed at a later date, prior to the implementation of the roadmap.
